## Adult entertainment permit application

Applications are accepted from 8:00 a.m. to 4:30 p.m. Monday – Friday at the Regulated Industries Division office. All applicants must be authorized to work in the United States. In order to submit an application for a manager's or entertainer's permit, applicants must submit a \$52 non-refundable application fee (checks are not accepted), a valid state issued driver's license or ID, and a Social Security card without employment restriction.

If an applicant is unable to submit a Social Security card, the application will be accepted but the applicant will be required to pick up the manager's or entertainer's permit in person at which time they *must* submit their Social Security card. If an applicant fails to submit their correct social security number, they will be required to pay an additional \$52 dollars to complete a second background check.

If an applicant submits a Social Security card *with* an employment restriction, they will need to submit one of the following: non-emergency U.S. passport, permanent resident card (i.e., green card), or employment authorization card. Fake, false or altered identification cards will be confiscated. Under the Code of Ordinances of the City of Kansas City, Missouri, there are some restrictions that may prohibit you from receiving a manager's or entertainer's permit. Please read below to determine if you are eligible to receive a manager's or entertainer's permit.

## **DIVISION 3. ISSUANCE**

## Sec. 12-57. Criteria for issuance of license or permit.

- (c) *Manager's or entertainer's permit.* The director shall investigate the application and report the findings of the investigation to the commissioner who shall issue any applicable permit authorized by this article if the commissioner finds that:
  - (1) The applicant has not made any false, misleading or fraudulent statement of material fact in the application for a license, or in the providing of documentation of age, as part of the original permit application or application for renewal thereof.
  - (2) The applicant has attained the age of 18 years.
  - (3) The applicant has not been convicted of a felony or released from confinement for conviction of a felony, whichever event is later, within five years immediately preceding the application, or has not been convicted of a misdemeanor or released from confinement for conviction of a misdemeanor, whichever event is later, within two years immediately preceding the application, where such felony or misdemeanor involved sexual offenses, prostitution, sexual abuse of a child or pornography and related offenses, as defined in the state's criminal code, RSMo chs. 556-600, or similar statutes, or controlled substance or illegal drugs or narcotics offenses, as described in the state comprehensive drug control act, or similar statutes, or has not been convicted of a municipal ordinance violation or released from confinement for conviction of a municipal ordinance violation, whichever event is later, within two years immediately preceding the application, where such municipal ordinance violation involved indecent exposure, prostitution, or sale of controlled substances or illegal drugs or narcotics.
  - (4) The applicant has not had a license or permit issued under the provisions of this article revoked within five years immediately preceding the application.
